Plan for Safe Return to In-Person Instruction and Continuity of Services

May 27, 2021

Background and Explanation:

"On March 11, 2021, President Biden signed the Federal American Rescue Plan Elementary and Secondary School Emergency Relief (ARP ESSER) Fund, Public Law 117-2, into law. ARP ESSER provides an additional \$122 billion to States and school districts to help safely reopen, sustain the safe operation of schools, and address the impact of the COVID-19 pandemic on the nation's students. As with the previous ESSER funds available under the Coronavirus Aid, Relief and Economic Security (CARES) Act, and the Coronavirus Response and Relief Supplemental Appropriations Act (CRRSA), the purpose of the additional funding is to support local educational agencies (LEAs) in preparing for and responding to the impact of COVID-19 on educators, students, and families.

The interim final requirements published by the U.S. Department of Education (USDE) on April 22, 2021 state, "each LEA that receives ARP ESSER funds must develop, submit to the SEA... and make publicly available on the LEA's website, a plan for the LEA's use of ARP ESSER funds... [u]nder this requirement, an LEA must engage in meaningful consultation with stakeholders and give the public an opportunity to provide input in the development of its plan." -New Jersey Department of Education

In accordance with the above, FTS has developed a Plan for Safe Return to In-Person Instruction and Continuity of Services for the 2021-2022 school year, outlining the topics requested in the grant application for the ARP ESSER. In addition, because FTS has been open for in-person learning since September, 2020 with a plan that included input from multiple community stakeholders, we will be continuing with our plan, making changes as necessary. Please note that updates will continue throughout the summer as changes are made to the guidelines from the CDC, New Jersey Department of Health and New Jersey Department of Education. Beginning now, the school community can review this information and provide public comment on the plan. 1. Maintaining Health and Safety

A. Universal and correct wearing of masks

- Students and staff will be instructed on the proper wearing of masks and the appropriate types of masks.
- The school will provide masks to anyone in need.
- The most current guidelines from the New Jersey Department of Health will be followed.

B. Physical distancing (e.g., including use of cohorts/podding)

Classrooms

- Desks and seats at tables will maintain 3-6 feet of distance.
- Small group work areas will maintain 3-6 feet of distance.
- The most current guidelines from the New Jersey Department of Health will be followed.

Hallways

- Hallways are marked with 3-6 feet of distance.
- Distance will be maintained while walking in the hallway.
- The most current guidelines from the New Jersey Department of Health will be followed.

Cafeteria

- Students will maintain 6 feet of distance while eating lunch.
- Schedules will divide lunch periods into 2 cohorts to minimize crowding in the cafeteria.
- Extra tables and chairs will be added as necessary.
- The most current guidelines from the New Jersey Department of Health will be followed.

Gym

- The gymnasium is marked with 6x6 feet boxes for students to participate in gym activities.
- The most current guidelines from the New Jersey Department of Health will be followed.

C. Hand washing and respiratory etiquette

- Students have scheduled hand washing time that includes before eating, after being outside and bathroom breaks. Other times may be scheduled in as necessary, depending on classroom activities.
- All students will be instructed by the school nurse and/or health teacher on proper hand washing techniques.
- Students will be instructed by the school nurse for respiratory etiquette (ex: covering coughs, sneezes, etc.)

D. Cleaning and maintaining healthy facilities, including improving ventilation

- Daily disinfection will continue to be a priority including desks, tables, bathrooms, and commonly touched surfaces.
- Classrooms are equipped with Medify Air Purifiers and will have filters changed as recommended by the manufacturer specs.
- Classroom univents will have filters changed periodically or as necessary.
- Classrooms are able to allow for fresh air flow with open windows.
- Ventilation will continually be assessed and upgraded as needed.
- The most current guidelines from the New Jersey Department of Health will be followed.

E. Contact tracing in combination with isolation and quarantine, in collaboration with the State, local, territorial, or Tribal health departments

- Contact tracing is done in collaboration with the County Health Department
- Isolation and quarantine times are determined by most current CDC and/or New Jersey Department of Health guidelines

F. Diagnostic and screening testing

- Diagnostic testing for Covid-19 will not be done in the district.
- Symptom screening and recommendations for testing will be done by the school nurse
- The most current guidelines from the New Jersey Department of Health will be followed.

- Every effort will be made to provide resources, time and information to educators and families regarding the vaccine
- The most current guidelines from the New Jersey Department of Health will be followed.

2. Ensuring Continuity of Services

Frelinghuysen Township School District will take the following steps to ensure a continuity of services:

- Assess student's academic needs to provide instructional materials to address both students in need of intervention and students in need of enrichment. Assessments will be standardized using research based assessments, benchmarks for grade level standards, classroom formative assessments and instructional summative assessments. Based on these assessments, funding will be used for additional instructional programs, materials and/or staffing will be provided as determined by need.
- Address students and staff social, emotional and mental health needs through appropriate mental health services such as an on-staff guidance counselor, research based SEL program, and professional development for staff. In addition, resources will be provided to any member of the school community in need of services, including health or food services. Funding will be used for these purposes as well.

Many of these practices have been in place since September, 2020, when the district re-opened for in-person learning.
