Public Budget Hearing – Mrs. Bonaparte presented the 2020-21 district budget. The budget maintains educational programming. There are 2 paraprofessional positions cut due to the students transferring out. There are funds budgeted for additional school security. The district has shared services contracts with Blairstown BOE for CST services and Pohatcong BOE for a Spanish teacher. It should be noted that the district lost approximate \$80,000 in state aid for the 2020-21 school year and that \$2.1 M of the \$2.7 M budget is the tax levy.
