### **Report of the Chief School Administrator**

- NJ Start Strong Results-
  - Students took NJ Start Strong in October. All students participated.
- There are three assessment levels:
  - 3-Less Support Needed
  - 2-Some Support Needed
  - 1-Strong Support Needed
- There were only 12 questions so this really provided a snapshot overall of where the kids are. Grades 4, 5, and 6 tested in ELA and Math. Grade 6 tested in Science too. This included Special Education students as well. Teachers along with the Interventionist will review the data along with everyday classroom performance. Areas are identified that require more reinforcement.
- The virtual holiday concert was amazing. The kids did a great job. We are considering an in person spring concert.
- For the Great Kindness Challenge the 6<sup>th</sup> grade has planned spirit week and a door decorating contest
- Pre-K and Kindergarten registration will be opening up.
- We are working with the PTO on spring clubs. There is grant money that may be used for afterschool programming.

- The PTO has donated new microscopes. We are grateful for the donation.
- The HIB self-assessment was completed with the School Safety Team. It was for September through June 2020-2021. Low areas identified have been corrected.
- Personnel items on the agenda include substitute increases which are much needed.
- We will be pulling Personnel P1 from the agenda.
