Report of the Chief School Administrator

- Hybrid Back to School went well with approximately 50% present and 50% virtual. The virtual option may be considered for the future. The feedback from parents was positive.
- Events for October will include the Week of Respect, Fire Prevention Week, Unity Day and Red Ribbon Week and Halloween.
- We will be applying for funding through the ARP-ESSER grant.
- A Strategic Planning Community Survey is being created to see what the public thinks of our school, improvements that can be made, etc. It will be an online survey with multiple choice, sliding scale and open ended questions for public response.
- The Executive Order regarding vaccine mandates extends to volunteers. They must be vaccinated or test weekly.
